**(Update on Disclosed Matter) Notice Concerning Recording of Extraordinary Income
(Gain on Sale of Investment Securities)**

Kyodo Printing Co., Ltd (hereinafter the “Corporation”) hereby announces that with regard to the “Notice Concerning Expected Recording of Extraordinary Income (Gain on Sale of Investment Securities)” released on May 15, 2025, the sale of the relevant investment securities has been completed, as described below.

1. Reason for sale of investment securities

To review policy shareholdings in accordance with the Corporate Governance Code, strengthen financial position and improve asset efficiency.

The Corporation plans to reduce the balance of policy shareholdings to less than 15% of consolidated net assets by the end of March 2028.

2. Details of sale of investment securities

(1) Investment securities sold	Eight listed stocks and one unlisted stock held by the Corporation
(2) Time of gain on sale	May 2025 to March 2026
(3) Gain on sales of investment securities	3,394 million yen

*The increase in gains over the initial estimate (approximately 2.8 billion yen) is primarily due to fluctuations in the stock prices of the sold securities and an increase in the number of securities sold..

3. Outlook for the future

The above gain on sales of investment securities is expected to be recorded as extraordinary income in the fiscal year ending March 2026. Regarding the consolidated earnings forecast for the fiscal year ending March 2026 announced on May 15, 2025, other factors are currently under review. Should revisions be necessary, we will promptly notify stakeholders.
